

FLWGA Board Meeting Minutes December 3, 2024

The December Board of Directors Meeting was called to order by President Leslie Tieszen at 2:01pm at the Westside Amenity Center. Members present were Leslie Tieszen, Becky Davis, Betty Detrich, Brook Mooney, Carol Cummings, Les Pryor, Vicki Flood and Sue Ellis. New 2025 Social Director, Julia Sivinski and Membership Director, Dana Aupperle also attended the meeting.

Vice President Report – Sue Ellis

Sue Ellis mentioned that she has been training Les Pryor to take over as the new Vice President in 2025. Sue Ellis shared that she currently maintains flwga.com through Wix which is renewed through October 2025 for \$220. Sue stated that the men's golf association only uses the portal, flmga.org.
