

FLWGA Board Meeting Minutes November 5, 2024

The November Board of Directors Meeting was called to order by President Leslie Tieszen at 2:02pm at the Westside Amenity Center. Members present were Leslie Tieszen, Becky Davis, Betty Detrich, Brook Mooney, Carol Cummings. Les Pryor and Sue Ellis. New 2025 Social Director, Julia Sivinski also attended the meeting

Vice President Report – Sue Ellis

Sue Ellis shared that Go Daddy renewed in November for approximately \$37. Sue also mentioned that Wix (FLWGA.com) is paid up until October 2025. She will be working to determine the viability of the site and whether all the functionality can be moved to the Golf Software Web Designer product. Sue will also be assisting Les Pryor as she takes over this BOD role in 2025.

Membership Report – Les Pryor

Les Pryor shared that the membership total is 112 members. Les also mentioned that she will begin training new 2025 Membership Director Dana Aupperle.

Social Director Report – Carol Cummings

Carol Cummings shared an update on the FLWGA Holiday Party that will be Wednesday, December 4th. Carol mentioned that Celebration will cater the event. The current estimated cost for 100 attendees is \$1438; however, Carol said she will order for 90 attendees and there will be sufficient funds for FLWGA to provide wine as well. Betty McKean is the Sponsor for the event and will also furnish dessert. Ugly Christmas sweaters will be the recommended attire for the party and each attendee will be asked to bring a white elephant gift. Carol will be working with Erin Garrison on the event flyer so it can be sent to membership as soon as possible.

Golf Director Report – Brook Mooney

Brook Mooney shared that the November 6th End-of-Year tournament, “Golfing with the Stars” has 36 players. It will be a shot-gun start, step-aside scramble format and the awards/social will be at 1:00pm in D&E. Brook also shared that Rose Whatley has decided not to be the Rules Coordinator for 2025 and Brook also mentioned that she will be looking for 9 and 18 hole coordinators for next year. Les mentioned that Sue Frisby has a template she developed for their neighborhood to solicit volunteers and also request feedback/suggestions from members. This form could be used by FLWGA and can be attached to members name tags at the Holiday Party. Brook also mentioned providing more focus in 2025 on the Ambassador Program for new members. During the BOD meeting, there was discussion around new member orientation, rules meeting, etc. for 2025.

Treasurer Report – Betty Detrich
